

In Memory of Ted Sapper

In December of 2003, The Sapper Family, of Indianapolis, Indiana would have their lives changed forever when the news arrived that their father, Theodore Sapper was diagnosed with a brain tumor. On March 16th, 2004, just over three months after his diagnosis, Theodore was lost to the Sapper family due to a glioblastoma multiforme (GBM) brain tumor.

Moved by his passing and the knowledge that over 50,000 people per year are affected by brain tumors, The Sapper Family decided to raise funds and awareness for brain tumors and the families that it affects.

Working with their friends and community as a whole, they created the annual "Head for the Cure" 5K Fun Run/Walk to benefit the American Brain Tumor Association.
